

In this report, you can learn of the successes of my Administration and our Delegation. We championed legislation for our young people with school construction and youth programs. Administration Legislative Priorities

Public Safety - Untraceable Firearms - SB387/HB425

BCA Position: Support | BPD Position: Support

Alters the definition of firearm to include ghost guns and prohibits a person from purchasing, receiving, selling, offering to sell, or transferring a ghost gun.

Public Health – Baltimore City Behavioral Health Crisis Incident Review Team – HB1222

BCA Position: Support

Establishes the Review Team to examine behavioral health crises that involve interaction with law enforcement in the City and recommend and facilitate changes to minimize the need for law enforcement involvement in behavioral health crises.

Baltimore City Youth Data Hub - Establishment - SB870/HB1276

BCA Position: Support

Establishes the BCYDH for the purpose of promoting well-being of youth and improving access to and cost-efficiency of youth programs. It also establishes an executive committee and provides for a manager to operate the Hub.

Health Records and Reporting of Overdoses – Limitations on Use in Criminal Investigation or Prosecution – SB568/HB786

BCA Position: Support

Prohibits overdose information reported by an emergency medical services provider from being obtained by a law enforcement officer as part of a criminal investigation or prosecution.

Baltimore City – Criminal Procedure and Public Safety – Courts and Criminal Justice in Baltimore City – SB586/HB441

BCA Position: Support | BPD Position: Support

Requires DPSCS to notify BPD within 24 hours of a pre-trial defendant being released and that the notice be provided in a manner that allows the sorting and filtering of the information.

Baltimore City - Vehicle Laws - Towing - SB750/HB1081

BCA Position: Support

Authorizing Baltimore City to tow vehicles blocking access to driveways, alleys, transit lanes, or parking facilities.

Baltimore City – Use of Highway User Revenues for Traffic Functions and Enforcement – Modification – SB729/HB1362

BCA Position: Support

Authorizes the City to use HUR to pay any cost incurred for carrying out traffic functions and enforcing the traffic laws.

Baltimore City - Alcoholic Beverages - Licenses and Outdoor Table Service Privileges – SB771/HB1115

BCA Position: Support

Alters the hours of sale and the annual license fee relating to a public market license in Baltimore City. Specifies circumstances under which the Baltimore City Board of License Commissioners may impose fees for a Temporary Outdoor Seating Permit. (Note: This bill was amended to reflect language from HB1447, a BCA priority)

Baltimore City – Cigarettes, Other Tobacco Products, and Electronic Smoking Devices – Local Laws Authorization – SB249/HB442

BCA Position: Support

Authorizes the City to enact and enforce local laws regulating the sale and distribution of cigarettes, other tobacco products, and electronic smoking devices.

Division of Parole and Probation – Duties – Offenders Under Supervision (Parole and Probation Performance Act) – SB587

BCA Position: Support

Alters the duties of the Division of Parole and Probation to include the examination and review of murders involving offenders under the supervision of the Division and advise the Secretary on policies and programs to prevent such murders.

Public Safety - Police Officers - Emergency Termination - SB864

BCA Position: Support | BPD Position: Support

Authorizes the chief of a law enforcement agency to terminate the employment of a police officer under egregious circumstances. Authorizes a police officer to appeal the police officer's termination from employment under the Act.

Baltimore Police Department – Consent Decree – Exceptions to State Law – SB866 BCA Position: Support | BPD Position: Support

Provides that if State law requirements are determined to be inconsistent with a consent decree, those State requirements will have no force or effect under certain circumstances.

Labor and Employment – User Name and Password Privacy – Law Enforcement Agencies – SB851

BCA Position: Support | BPD Position: Support

Authorizes law enforcement agencies to access social media accounts of applicants, and prohibits agencies from keeping an applicant's username, password, or other means of access.



Economic Development

Baltimore City - Alcoholic Beverages - Licenses and Outdoor Table Service Privileges - SB771/HB1115

BCA Position: Support

Alters the hours of sale and the annual license fee relating to a public market license in Baltimore City. Specifies circumstances under which the Baltimore City Board of License Commissioners may impose fees for a Temporary Outdoor Seating Permit.

(Note: This bill was amended to reflect language from HB1447, a BCA priority)

Economic Development - Enterprise Zone Program - Alterations - HB478

BCA Position: Oppose

Establishes the purpose of the Program and requires each county that has an enterprise zone to submit a yearly report to the MDC.

Economic Development – Maryland Makerspace Initiative Program – SB453

BCA Position: Support

Creates the Program to encourage the establishment of makerspaces throughout the State and partnerships to provide technical and financial assistance to nonprofit entities and local governments.

Maryland Stadium Authority – Increase of Bond Authorization – Camden Yards – HB896

BCA Position: Support

Alters the amount of taxable or tax-exempt bonds that the MSA may issue for certain sports facilities at Camden Yards and the purposes for which the proceeds from those bonds may be utilized.

Baltimore City – Small Box Discount Stores – Zoning Requirements and Community Agreements – SB869

BCA Position: Letter of Information

Authorizes the City to establish requirements and take certain actions regarding the location of and use of a property as a small box discount store, or \$5 or less store. Requires the City to conduct a comprehensive diversity study.

Economic Development – Project Restore Program and Fund – SB393/HB414

BCA Position: Support

Establishes the Program within MDHCD to provide financial incentives for small businesses, commercial developers, and nonprofit organizations to revitalize certain vacant retail and commercial space.

Omnibus Procurement Reform Act ("OPRA") of 2022 - HB1353

BCA Position: Oppose

Makes the purposes and policies of State procurement law apply to county procurements that include any State funds, and it gives the MSBCA jurisdiction to hear and decide appeals related to those local procurements. Makes various changes to State procurement policies and procedures.

Constitutional Amendment – Beer and Wine Licenses – Retail Grocery Establishments – SB603/HB506

BCA Position: Support

Proposes an amendment to the Constitution of Maryland to establish that a retail grocery establishment in the State may obtain a license authorizing them to sell beer and wine and submitting the amendment to the qualified voters at the November 2022 general election.

Housing and Community Development

Landlord and Tenant – Stay of Eviction Proceeding for Rental Assistance Determination – SB384/HB674

BCA Position: Support

This emergency bill provides for a stay of eviction proceedings when a tenant is waiting for a determination on a good faith application for rental assistance.

Vetoed by Governor Hogan.

Landlord and Tenant and Wrongful Detainer Actions – Eviction Prevention Services – SB564/HB691

BCA Position: Support

Requires the court to grant a recess to allow the movant to use eviction prevention services and a continuance if either party seeks legal representation, witnesses, documents or other proof of a claim of defense.

Real Property - Nuisance Actions - Rodent Harborage - HB263

BCA Position: Oppose

Authorizes an individual to bring a nuisance action for damages caused by rodent harborage against a property owner, unless the rodent harborage occurs on property zoned for agricultural use.

Historic Revitalization Tax Credit – Funding and Extension – SB289/HB27

BCA Position: Support

Alters the Program by extending the termination date. Requires the Governor to provide a minimum appropriation to the existing program and the small commercial project trust account. Increases the maximum value of the commercial tax credit.

Mold Inspections and Remediation – Standards, Reporting, Penalties, and Tax Credit – SB320/HB361

BCA Position: Support

Requires MDE to establish uniform standards for mold assessment and remediation. Authorizes a tenant to deposit the tenant's rent in an escrow account under certain circumstances. Authorizes a tax credit for taxpayers of certain residential properties who incur mold remediation costs.

Taxes

Baltimore City - Homestead Property Tax Credit - Notice - HB642

BCA Position: Support

Requires the City to provide mailed notice of the homestead property tax credit to homeowners whose dwellings have increased in value by more than 10%.

Income Tax - Film Production Activity Tax Credit - Digital Animation Projects - SB536

BCA Position: Support

Expands eligibility for the credit against the State income tax for certain film production activities to include certain digital animation projects.

Tax Sales - Alternative Collection Programs - HB1196

BCA Position: Support

Repeals the termination date of the authority of a county or municipal corporation to withhold from tax sale owner-occupied residential property and requiring the property to meet certain criteria. Authorizes a county or municipal corporation to cancel or postpone a tax sale during a state of emergency.

Baltimore City – Tax Sales – Nonprofit Entity–Owned Real Property – HB509

BCA Position: Oppose

Alters the list of properties that must be withheld from a tax sale to include property owned by a nonprofit entity that is exempt from taxation under specified provisions and collects less than \$750,000 in annual donations exclusive of government funds.

Income Tax - Film Production Activity Tax Credit - Alterations - HB432

BCA Position: Support

Increases the film production activity tax credit certificates that the Secretary of Commerce may issue.

Property Tax - Constant Yield Tax Rate - Notice Requirements - SB543/HB445

BCA Position: Support

Modifies specified advertising requirements that local jurisdictions must follow regarding the constant yield tax rate by establishing a separate notification requirement for jurisdictions that maintain their real property tax rate from the prior year.

Property Tax Exemption – Religious Group or Organization – Third-Party Leases – SB760 BCA Position: Support

Provides that real property owned by a religious group or organization that is leased to a third party does not qualify for a certain property tax exemption, and if only part of the real property is leased to a third party, only that part so leased does not qualify for the exemption.

Health Equity and Human Services

Health Records and Reporting of Overdoses – Limitations on Use in Criminal Investigation or Prosecution – SB568/HB786

BCA Position: Support

Prohibits overdose information reported by an emergency medical services provider from being obtained by a law enforcement officer as part of a criminal investigation or prosecution.

Public Health – Baltimore City Behavioral Health Crisis Incident Review Team – HB1222

BCA Position: Support

Establishes the Review Team to examine behavioral health crises that involve interaction with law enforcement in the City and recommend and facilitate changes to minimize the need for law enforcement involvement in behavioral health crises.

Maryland Medical Assistance Program – Dental Coverage for Adults – SB150/HB6

BCA Position: Support

Requires the program to provide dental services for adults whose annual income is at or below 133% of the federal poverty level.

Alzheimer's Disease and Dementia – Council and Coordination of Services (Dementia Services Act of 2022) – SB27/HB166

BCA Position: Support

Renames the Council, establishes term limits, and requires the Council to issue and publish a plan every 5 years.

Behavioral Health Crisis Response Services - 9-8-8 Trust Fund - SB241/HB293

BCA Position: Support

Establishes the Trust Fund as a special, nonlapsing fund to provide reimbursement for costs associated with designating and maintaining 9-8-8 as the universal telephone number for a national suicide prevention and mental health crisis hotline.

Maryland Health Benefit Exchange – Small Business and Nonprofit Health Insurance Subsidies Program – SB632/HB709

BCA Position: Support

Requires the MHBE to convene a workgroup to study and make recommendations relating to the establishment of the Program to provide subsidies to small businesses and nonprofit employers and their employees.

Maryland Medical Assistance Program – Community Violence Prevention Services – SB350/HB1005

BCA Position: <u>Support</u>

Requires the Program to provide community violence prevention services and establishes certification requirements for professionals and entities.

Access to Counsel in Immigration Proceedings Program – SB129/HB114

BCA Position: Support

Establishes the Program and creates funding to provide access to legal representation for covered individuals detained in immigration proceedings.

Indigenous Peoples' Day – Rule of Interpretation and Replacement of Columbus Day – HB565

BCA Position: Support

Replaces Columbus Day with Indigenous Peoples' Day in relevant provisions of the law.

Department of Aging – Dementia Care Coordinator and Dementia Care Navigation Programs – SB505/HB731

BCA Position: Support

Establishes the position of Coordinator in the MDOA to manage the work of dementia care navigators and requires each area agency to employ a dementia care navigator.

County Boards of Health and Baltimore City Health Department – Procedures and Appeals Process – SB330/HB761

BCA Position: Oppose

Requires each county board of health to establish certain requirements and an appeals process regarding inspections, issuances of a citation, or issuances of an order to cease operation; requiring each county board of health to publish the requirements and the appeals process on their websites

Health – Food Service Facilities – Beverage Options with Children's Meal – SB263/HB661 BCA Position: Support

Requires restaurants that offer children's meals to offer water, milk or a nondairy milk, etc. as the default beverages included with the meal.

Health Insurance – Home Test Kits for Sexually Transmitted Diseases – Required Coverage – SB634

BCA Position: Support

Requires health insurance policies and contracts to provide coverage for the purchase of home test kits to test for sexually transmitted diseases if the test is ordered by an in-network provider under certain circumstances.

Maryland Medical Assistance Program – Affordable Assisted Living Enhanced Care Pilot Program – SB743

Commission on Aging Position: Support

Establishes the Pilot Program to establish affordable assisted living enhanced care residences to eligible adults who are at least 60 years old.

Workgroup on Food Environments – HB179

BCA Position: Support

Establishes the Workgroup to determine and make recommendations regarding the most cost-effective method for producing a report on the food environment in each legislative district.

Workers' Compensation – COVID–19 Occupational Disease Presumption – SB10

BCA Position: Oppose

Establishes that first responders, public safety employees, and health care workers are presumed to have an occupational disease that is compensable under workers' compensation law after a positive test or diagnosis for COVID-19.

Cigarettes, Tobacco Products, and Electronic Smoking Devices – Local Law Authorization – SB99/HB477

BCA Position: Support

Authorizes a county or municipality to enact and enforce local laws regulating the sale and distribution of cigarettes, other tobacco products, and electronic smoking devices.

Baltimore City – Cigarettes, Other Tobacco Products, and Electronic Smoking Devices – Local Laws Authorization – SB249/HB442

BCA Position: Support

Authorizes the City to enact and enforce local laws regulating the sale and distribution of cigarettes, other tobacco products, and electronic smoking devices.

Recreation and Parks

State and Local Parks – Playground Accessibility – Communication Boards – SB680/HB1332

BCA Position: Oppose

Requires the MDNR and local governing bodies to construct a communication board in public playgrounds, which would display photos, symbols, or illustrations to enable individuals with limited language skills to express themselves and communicate.

Program Open Space – Local Plans and Programs – General Assembly Approval – SB56 BCA Position: Oppose

Requires approval through legislation before any local annual or revised program under Program Open Space takes effect or any grant agreement based on the annual or revised program is executed.

Youth and Education

Baltimore City Youth Data Hub - Establishment - SB870/HB1276

BCA Position: Support

Establishes the BCYDH for the purpose of promoting well-being of youth and improving access to and cost-efficiency of youth programs. It also establishes an executive committee and provides for a manager to operate the Hub.

Child Care Stabilization Grant Program and Child Care Expansion Grant Program – Established – SB480/HB89

BCA Position: Support

Requires MSDE to administer grants to provide financial support to child care providers that have faced a financial hardship or suffered an operational burden during the COVID-19 pandemic.

School Construction – Design Documents – Waste Disposal Infrastructure – HB566 BCA Position: <u>Support</u>

Requires the adoption regulations for local school systems to include waste disposal infrastructure in the design documents submitted for the construction of a new school building.

Education – Public School Construction – Funding and Administration – HB1290

BCA Position: Support

Requires certain actions relating to public school construction, including increasing the State share of public school construction project costs and inspecting systems and equipment during inspections of school buildings.

Outdoor Preschool License Pilot Program – Establishment – HB376

BCA Position: Support

Establishes a program to license outdoor, nature-based early learning and child care programs in order to expand access to affordable, high-quality early learning and child care programs and investigate the benefits of outdoor, nature-based classrooms.

Public Schools – Grant Program to Reduce and Compost School Waste – SB124/HB150

BCA Position: Support

Establishes a program to award grants to develop and implement programs for reducing food waste and composting of consumer waste.

Sustainability and Environmental Protections

Maryland Energy Administration – Resiliency Hub Grant Program and Fund – SB256/HB31

BCA Position: Support

Establishes the Program in the MEA to develop resiliency hubs that serve low- and moderate-income households, at no cost to the households, to provide electricity during extended grid outages.

Maryland Paint Stewardship - SB143/HB18

BCA Position: Support

Requires paint producers to submit a plan for the establishment of a Paint Stewardship Program to the MDE and in accordance with certain requirements.

Environment - Packaging Materials - Producer Responsibility - SB292/HB307

BCA Position: Support

Requires the MDE to conduct a statewide recycling needs assessment every 10 years. Also requires producers of certain packaging materials to submit a producer responsibility plan and prohibits a producer of certain packaging materials from selling or distributing the materials unless the producer has an approved producer responsibility plan.

Environment – Plastic and Glass Products – Postconsumer Recycled Content Program – HB1239

BCA Position: Support

Prohibits producers of certain plastic and glass products from selling, offering for sale, or distributing the products to any person in the State unless certain conditions are met and requires producers of certain plastic and glass products to register and pay an annual registration fee of \$1,000 to the DoE Department of the Environment.

Environment - Single-Use Plastics - Restrictions - HB135

BCA Position: Support

Prohibits food service businesses from providing single-use food or beverage products to a customer ordering carryout, delivery, or dining inside, unless the customer requests it.

Maryland Forestry Education Fund – Establishment – HB876

BCA Position: Support

Establishes the Fund to provide education and resources to forest landowners, expand the ability of district forestry boards and the knowledge of local governments to achieve healthy and sustainable forests, and the ability of to test innovative best management practices.

Reducing Greenhouse Gas Emissions – Commercial and Residential Buildings – HB831

BCA Position: Support

Requires the MDE to establish emissions standards for commercial and residential buildings, establishes the Building Energy Transition Implementation Task Force to develop a plan for funding the retrofit of certain buildings, and requires the MDL to update Performance Standards.

Task Force on Recycling Policy and Recycling and Waste Systems in Maryland – HB217 BCA Position: Support

Establishes a Task Force to review the Maryland Recycling Act, study the recycling and waste systems in Maryland, and make recommendations to update such Act.

Chesapeake and Atlantic Coastal Bays 2010 Trust Fund – Use of Funds (Chesapeake Bay Lockbox Protection Act of 2022) – SB366/HB921

BCA Position: Support

Establishes the Trust Fund to provide financial resources for nonpoint source pollution control projects in the State and prohibits the transfer of these funds to the General Fund or a special fund of the State.

Chesapeake Bay Restoration Fund – Authorized Uses (Chesapeake Bay Restoration Fund Lockbox Act of 2022) – HB1311

BCA Position: Support

Restricts the use of the Chesapeake Bay Restoration Fund to directly addressing pollution from wastewater treatment facilities, on-site sewage disposal systems, sewer systems, and stormwater management systems.

Public Safety and Justice Reform

Public Safety - Untraceable Firearms - SB387/HB425

BCA Position: Support | BPD Position: Support

Alters the definition of firearm to include ghost guns and prohibits a person from purchasing, receiving, selling, offering to sell, or transferring a ghost gun.

Baltimore City – Criminal Procedure and Public Safety – Courts and Criminal Justice in Baltimore City – SB586/HB441

BCA Position: Support | BPD Position: Support

Requires DPSCS to notify BPD within 24 hours of a pre-triahbl defendant being released and that the notice be provided in a manner that allows the sorting and filtering of the information.

Public Safety – Warrants and Absconding – SB585

BPD Position: Support

Requires the Governor to include in the annual budget bill an appropriation of \$2.0 million for local law enforcement agencies to be used as grants for warrant apprehension efforts. An agency that receives a grant must submit specified information to the GOCCP. The bill also modifies the definition of "absconding" as it relates to parole and probation.

Task Force to Study Public Information Act Requests Made to Law Enforcement – Establishment – SB777

BPD Position: Oppose

Establishes the Task Force to Study Public Information Act Requests Made to Law Enforcement.

Criminal Law – Sexual Crimes – Fourth–Degree Sexual Offense and Spousal Defense – SB33/HB153

BCA Position: Support

Repeals an exemption from prosecution for specified sexual crimes if, at the time of the alleged rape or sexual offense, the person was the victim's legal spouse.

District Court - Concurrent Civil Jurisdiction - Violation of Ordinances - HB1448

BCA Position: Support

Establishes that the District Court has concurrent civil jurisdiction with a county or Baltimore City over a proceeding for adjudication of a violation of certain ordinances.

Baltimore City - District Court - Jobs Court Pilot Program - SB602/HB785

BCA Position: Support

Establishes the Program in the Baltimore City District Court to reduce recidivism by offering opportunities in full-time job training and job placement programs as a condition of probation, an alternative to incarceration, or a condition of pretrial release.

Baltimore City – Board of License Commissioners – Licensee Hours of Operation – SB222/HB372

BPD Position: Support

Requires establishments located on "The Block" to close by 10:00 p.m., unless they meet specified conditions and security plans. Requires establishments to maintain and operate digital surveillance systems that are accessible by the city and to hire two BPD officers between the hours of 10:00 p.m. and 3:00 a.m. each week on Thursday, Friday, and Saturday.

Civil Rights - Violation of Rights - Governmental Liability - HB463

BCA Position: Oppose

Establishes the civil liability of a police officer who deprives an individual of certain rights under the Maryland Declaration of Rights and the Maryland Constitution. Requiring that the employer of a police officer indemnify the law enforcement officer against a judgment or settlement entered against the officer under the Act subject to certain exceptions.

Public Information Act – Inspection of Records from Body–Worn Digital Recording **Devices - SB31**

BCA Position: Support

Establishes requirements for a custodian of records related to body-worn recording devices worn by law enforcement officers and requires the development of uniform standards and policies.

Courts – Prohibited Indemnity and Defense Liability Agreements – SB161/HB79

BCA Position: Oppose

Prohibits a provision in a contract with a design professional that requires the professional to indemnify or hold harmless certain parties unless the design professional is at fault for causing the loss, damage, or expense indemnified.

Criminal Law – Threat Against Public Health Official or Hospital Staff Member – SB298/HB267

BCA Position: Support

Prohibits a person from threating a public health official or hospital staff member with the intent to intimidate, interfere with, or impede the performance of duties.

Criminal Procedure – Restorative Justice Program – SB850/HB997

BCA Position: Support

Establishes the Program within the Victim Services Unit of the GOCCP and creates a staff position, a fund, and a council.

Criminal Procedure – Warrantless Arrest – Straw Purchase Participant – HB211

BCA Position: Support | BPD Position: Support

Adds the crime of knowingly being a participant in a straw purchase of a regulated firearm to the list of crimes subject to warrantless arrest, and a sentence not to exceed 10 years or a fine of up to \$25,000 or both.

Baltimore City - Civilian Review Board - SB441/HB991

BCA Position: Letter of Information | Legal Opinion: Oppose

Alters the powers and duties of the Baltimore City Civilian Review Board and authorizes the Board to function as a police accountability board.

Workgroup to Study the Impact of Court-Mandated Fines and Fees – HB1199

BCA Position: Support

Establishes the Workgroup to study fines, specifically as it relates to low-income residents, and develop a plan and legislative recommendation for eliminating or reducing fines and fees.

Baltimore Police Department – Firearm Destruction, Seizure, and Recovery – Reporting Requirement – SB667

BPD Position: Support

Requires BPD to report information to the Baltimore City Delegation regarding firearms destroyed, seized, or recovered each year; if BPD does not submit a report as required under this Act, GOCCP may not award any grant funds.

Division of Parole and Probation – Duties – Offenders Under Supervision (Parole and Probation Performance Act) – SB587

BCA Position: Support

Alters the duties of the Division of Parole and Probation to include the examination and review of murders involving offenders under the supervision of the Division and advise the Secretary on policies and programs to prevent such murders.

Public Safety – Police Officers – Emergency Termination – SB864

BCA Position: Support | BPD Position: Support

Authorizes the chief of a law enforcement agency to terminate the employment of a police officer under egregious circumstances. Authorizes a police officer to appeal the police officer's termination from employment under the Act.

Baltimore Police Department - Consent Decree - Exceptions to State Law - SB866

BCA Position: Support | BPD Position: Support

Provides that if State law requirements are determined to be inconsistent with a consent decree, those State requirements will have no force or effect under certain circumstances.

Labor and Employment – User Name and Password Privacy – Law Enforcement Agencies – SB851

BCA Position: Support | BPD Position: Support

Authorizes law enforcement agencies to access social media accounts of applicants, and prohibits agencies from keeping an applicant's username, password, or other means of access.

Transit Safety and Equity

Baltimore City - Vehicle Laws - Towing - SB750/HB1081

BCA Position: Support

Authorizing Baltimore City to tow vehicles blocking access to driveways, alleys, transit lanes, or parking facilities.

Baltimore City – Use of Highway User Revenues for Traffic Functions and Enforcement – Modification – SB729/HB1362

BCA Position: Support

Authorizes the City to use HUR to pay any cost incurred for carrying out traffic functions and enforcing the traffic laws.

Vehicle Laws – Dedicated Bus Lanes – Prohibition and Monitoring Systems – HB53

BCA Position: Support

Prohibits a person from driving a motor vehicle in a dedicated bus lane unless authorized by a local jurisdiction. Requires BPD to issue a warning notice in place of a citation to a liable owner during the first 45 days that the bus lane monitoring system is in operation.

Motor Vehicles – Speed Limits – Establishment and Enforcement – SB520/HB434

BCA Position: Support

Authorizes Baltimore City to decrease or raise the maximum speed limit on a highway under its jurisdiction. Prohibits a local jurisdiction from using a monitoring system without performing an engineering and traffic investigation.

Transportation – Investment Program – MARC Rail Service (Maryland Regional Rail Transformation Act) – SB514/HB778

BCA Position: Support

Requires the MTA to establish investment programs for enhancing certain rail lines and services operated by the MARC rail service. Requires the MTA to advance certain rail projects and conduct a MARC Cornerstone Plan Implementation Study.

Transportation – Highway User Revenues – Revenue and Distribution – SB726/HB1187

BCA Position: <u>Support</u>

Alters the amount of income tax revenue from corporations that is distributed to a certain fund each year and alters the amounts of capital grants calculated based on highway user revenues that are required to be to Baltimore City, counties, and municipalities.

Greater Baltimore Transit Governance and Funding Commission – HB1336

BCA Position: <u>Support</u>

Establishes the Commission to study and make findings and recommendations relating to the funding, governance, and performance of mass transit in the greater Baltimore region. *Vetoed by Governor Hogan*.

Maryland Automobile Insurance Fund – Installment Payment Plans – SB278/HB377

BCA Position: Support

Alters restrictions and requirements related to the authority of the Fund to accept premiums on an installment payment basis for motor vehicle liability insurance policies.

Baltimore City – Complete Streets and Safe Routes to School Programs – Funding – HB73BCA Position: Support

Requires the City to spend the remaining balance of fines collected from certain traffic violations on activities related to the Safe Routes to School Program or public safety or transportation infrastructure improvements consistent with the goals of the Complete Streets Program.

Baltimore City – Maryland Transit Administration – Transit Services for Public School Students – SB862/HB1056

BCA Position: Support

Requires the MTA to provide ridership on transit vehicles to BCPSS students and youth workers in the Baltimore City YouthWorks program; Also prohibits the MTA from seeking reimbursement.

Vehicle Laws - Parking Enforcement - HB63

BCA Position: Oppose

Requires a police officer to compare the make and style of a vehicle with the make and style for the vehicle contained in the registration records on file with the MVA before issuing a parking citation.

Traffic Control Signal Modernization Fund – Establishment – HB925

BCA Position: Oppose

Establishes the Fund to finance the upgrading of traffic control signals in the State and requires the MTA to develop and implement a plan for upgrading traffic control signals in the State.

Driver's Licenses – Suspension for Child Support Arrearages – Exception – SB884/HB1293

BCA Position: Support

Establishes an exception to the authority of the Child Support Administration to notify the MVA of an individual's child support arrearages for the purpose of suspending the individual's driver's license if the obligor's family income is not greater than 300% of the federal poverty level.

Street Racing, Exhibition Driving, and Noise Abatement – Prohibited Acts, Enforcement, and Penalties – SB612

BPD Position: Support

Increases penalties for violations for participating in racing or speed contests. Also establishes a statewide prohibition on exhibition driving on any highway or private property. Lastly, authorizes a police officer to order the towing and impounding of these vehicles.

Automated Enforcement – Exclusion of Vehicle Rental Companies – Repeal and Notification Requirement – HB230

BCA Position: Support with Amendments

Repeals an exclusion, subjects a motor vehicle rental company, as the owner of a vehicle, to enforcement of certain automated enforcement violations. Establishes a process for issuing citations to any such companies and makes other conforming changes.





State Aid to Baltimore City¹

State Aid Overview

- Baltimore City will receive \$1.4 billion in State aid in fiscal 2023. Of this amount, \$1.3 billion is direct aid, and \$61.5 million is for retirement payments.
- Baltimore City will receive a 4.0% increase in State funding in fiscal 2023, with total State aid increasing by \$54.2 million over the prior year. Direct aid increases by \$57.7 million, while retirement payments decrease by \$3.5 million.
- On a per capita basis, Baltimore City ranks second with State aid totaling \$2,397 per resident. This compares to the statewide average of \$1,494 per resident.

Proposed Enhancements

- The proposed State budget includes \$45.9 million in additional funding for the police aid formula. The allocation is based on county population (\$6.46 per capita) and the number of municipal sworn officers (\$975 per officer). Baltimore City receives \$8 million under the formula enhancement.
- Regarding public school funding, the Administration provided an additional \$57.3
 million in hold harmless grants under the compensatory aid program to offset
 declines in the free and reduced-price meal (FRPM) count. Since Baltimore City's
 funding under this program did not decrease from the prior year, the school system
 was not eligible for a hold harmless grant.
- The Administration also provided an additional \$68.1 million for full-day prekindergarten programs that exceeded the requirements under the Blueprint Plan. The Administration provided per student funding regardless of family income. Under the Blueprint Plan, full-day prekindergarten funding is targeted for the lowest income families at 300% of the federal poverty level. Baltimore City will receive \$8.9 million of this additional funding.
- However, the additional discretionary enhancements to education aid are offset by the Administration's underfunding of the Education Effort Index that provides additional funding to Baltimore City (\$99.0 million) and Prince George's County (\$26.5 million).

City Government Aid

• Baltimore City government will receive nearly \$297 million in State aid, which represents a \$3.4 million, or 1.2%, increase from the prior year.

• State funding includes \$170.0 million for highway user revenues, \$15.3 million in targeted crime grants, \$64.9 million in disparity grants, \$25.4 million in gaming impact aid, and \$1.3 million for fire and rescue aid.

Public Safety Grants

- Baltimore City will receive \$8.0 million under the proposed police aid enhancement.
- Currently, Baltimore City does not receive funding under the police aid formula.
 Baltimore City was excluded from the program in fiscal 1992 due to the State's
 assumption of the Baltimore City Detention Center (now the Baltimore Pretrial
 Complex) and the establishment of the Baltimore Central Booking and Intake
 Facility. In fiscal 1997, the police aid formula was adjusted to provide Baltimore City
 with a relatively small supplemental grant (\$0.50 per resident). However, in recent
 years, this funding amount has been canceled out by the crime lab reimbursement
 requirement.
- The fiscal 2023 State budget includes \$168.5 million to operate the Baltimore Pretrial Complex and the Baltimore Central Booking and Intake facility.
- Baltimore City will receive \$15.3 million in funding through four targeted crime initiatives in fiscal 2023. This includes \$9.2 million for direct police grant, \$3.6 million for safe streets, and \$1.8 million for the State's Attorney's Office. Funding for these initiatives has remained fairly stable in recent years.
- Baltimore City will receive \$1.3 million in fire and rescue aid in fiscal 2023. Each
 county's funding is based on their share of property tax accounts relative to the
 statewide total. Each county is guaranteed a minimum 2% share of total funds
 (\$300,000).

Local Health Grants

• Baltimore City will receive \$10.2 million in local health grants in fiscal 2023. Statewide, local health departments will receive \$74.9 million, which represents a \$1.0 million increase from the prior year.

Transportation Aid

- Legislation enacted in 2018 (Chapters 330 and 331) required the State to provide capital transportation grants to local governments based on the amount of revenue allocated to the Gasoline and Motor Vehicle Revenue Account. The local share will total 13.5% in fiscal 2020 to 2024. Baltimore City receives 8.3%, county governments receive 3.2%, and municipal governments receive 2.0%.
- In fiscal 2023, the Baltimore City government will receive \$170.0 million, which accounts for 61.5% of total State funding under the program.
- Baltimore City has generally received a larger share of local highway user revenues than other jurisdictions because the State does not conduct highway maintenance or construction within the city (except for portions of I-95).

Disparity Grants

- Baltimore City will receive \$64.9 million in funding under the disparity grant program in fiscal 2023, which represents a \$11.3 million decrease from the prior year.
- The decrease in funding under the program is due primarily to the growth in local income wealth within the city. The narrowing of income wealth disparities between Baltimore City and other jurisdictions results in a lower disparity grant. Over the past 12 years, Baltimore City has led the State in the average annual increase in per capita income tax yield, which is the main component of the disparity grant program.
- The disparity grant program provides State funding to 10 jurisdictions where per capita revenue collections from the local income tax is below 75% of the statewide average. Under the program, each eligible jurisdiction receives a grant that enables the per capita local income tax revenues to reach 75% of the statewide average.

Gaming Impact Aid

Baltimore City will receive \$25.4 million in gaming impact aid in fiscal 2023.

Local Library

 Baltimore City will receive \$9.5 million in local library aid in fiscal 2023. In addition, \$11.9 million in funding is provided to the Enoch Pratt Free Central Library through the State Library Network since the library is designated as the State Library Resource Center.

Education Aid

- Over 75% of State aid to Baltimore City will go to public schools. Baltimore City Public School System will receive over \$1 billion in direct aid in fiscal 2023, which represents a \$54.2 million, or 5.6%, increase from the prior year. In addition, the State will provide \$59.0 million in funding for teacher retirement payments.
- On a per pupil basis, Baltimore City will receive \$15,201 in State funding: \$14,374 per pupil in direct aid; and \$826 per pupil for teacher retirement payments. Baltimore City ranks second in the amount of per pupil direct aid.
- In terms of year-over-year funding enhancements, Baltimore City will receive an 8.1% increase in per pupil direct aid, which is the fifth highest increase in the State. For comparison purposes, per pupil direct aid increases by 5.4% on a statewide basis.

Blueprint and Targeted Funding

Mayor Brandon M. Scott

- Baltimore City will also receive \$136.8 million in additional State funding under the Blueprint Initiatives in fiscal 2023. This includes \$8.7 million for supplemental instruction, \$82.4 million in concentration of poverty grants, and \$25.9 million for fullday prekindergarten.
- A considerable amount of State education funding is based on targeted student populations, with Baltimore City receiving \$404.3 million in targeted grants under

the compensatory aid, English Language Learners (ELL), and special education programs. Baltimore City receives the highest amount of funding on a per pupil basis (\$5,666).

Student Enrollment

- The full-time equivalent student (FTES) enrollment count decreases by 2.3% in Baltimore City compared to the statewide average decrease of 0.7%. This results in 1,709 fewer students for the Baltimore City Public School System. Currently, the city school system accounts for approximately 8.4% of students statewide.
- The number of students approved for free and reduced-price meals (FRPM) decreases by 1.4% in Baltimore City compared to the statewide average decrease of 6.9%. Baltimore City currently has the highest percentage of students approved for FRPM at 88.4% of total student enrollment.
- Baltimore City has the fourth highest percentage of students identified as ELL at 11.4% of total student enrollment. In fiscal 2023, the number of ELL students increases by 14.2%, resulting in 1,013 additional students requiring language services.
- Baltimore City has a relatively higher share of students receiving special education services. In fiscal 2023, the number of students receiving special education services accounts for 16.3% of total enrollment, compared to the statewide average of 12.8%.
- Baltimore City has the highest targeted student index in the State at 116.1%. This index adds together the percent share of FTES who are approved for FRPM, ELL, and special education services. The targeted student index has a statewide average of 62.5%.
- Statewide, public school enrollment represents 13.7% of the total State population. In Baltimore City, public school enrollment represents 12.2% of the overall city population (the nineteenth highest in the State). Public school enrollment as a share of total county population ranges from 8.9% in Kent County to 16.8% in Howard County.

2. Retirement Payments

City teachers and librarians are members of either the teachers' retirement or pension systems maintained and operated by the State. The State pays a portion of the employer share on behalf of the subdivisions for these local employees. Fiscal 2023 State payments for Baltimore City for teachers and librarians are estimated to be \$61,532,000.

Estimated State Spending on Selected Health and Social Services

The Maryland Department of Health; the Department of Aging; the Department of Human Services; the Department of Housing and Community Development; and the Governor's Office of Crime Prevention, Youth, and Victim Services fund the provision of health and social

A new page will open that contains the bill history as well as a synopsis of the bill. Detailed analysis and the background of each bill are found in the "Fiscal Note" document at the bottom.

Bills that have already been signed into law (enacted) will have "Chapter" identified after the bill number on the General Assembly's website. If the Governor does not act on a bill that has been presented within 20 days of adjournment of the General Assembly by signing it into law or vetoing it, the bill will automatically become law.
